This race program will be run under Eldora Speedway (Eldora) rules, and in signing an Official Entry Form (OEF) or taking part in any of the events described in this OEF, all competitors acknowledge that they have received, read and understand all of the rules and regulations associated with the event, and hereby agree to abide by all official Eldora decisions and regulations. Any deviation of these rules and regulations may result in fines or penalties including disqualification from the event.



UMP DIRTcar National Points: Each Feature Race contested during the Dirt Late Model Dream weekend will offer competitors the opportunity to score points towards the UMP DIRTcar National Championship.

The Twin 25's Features on both Thursday and Friday plus Saturday's Dirt Late Model Dream presented by Ferris Commercial Mowers will each award points using UMP DIRTcar's 80 point schedule: 1st) 80; 75; 70; 65; 60; 55; 53; 51; 49; 47; 45; 44; 43; 42; 41; 40; 39; 37; 36; 35; 34; 33; 32; 31; 30; etc.

Saturday's B-Feature Scrambles will each award points using UMP DIRTcar's 75 point schedule: 1st) 75; 70; 65; 60; 55; 50; 48; 46; 44; 42; 40; 39; 38; 37; 36; 35; 34; 33; 32; 31; 30; 29; 28; 27; etc.

You only score points from a finish in a Feature event from which you do not advance to another Feature event (ex. Finishing 3rd after 20 laps in the B-Feature to advance to the Dirt Late Model Dream means you score points from your finish in the Dirt Late Model Dream).

1. Minimum age for competitors is 16 years of age as of June 4, 2014. Only persons 14 years of age or older will be admitted to pit area. Minors 14, 15, 16 or 17 years of age submit a Parental Consent, Release and Waiver of Liability, Assumption of Risk, and Indemnity Agreement/Minor's Assumption of Risk and Release and Waiver of Liability signed by BOTH of their parents (or legal guardians). 2. One entry per driver. Cars will be sealed at Inspection and Registration. Backup cars will only be permitted if the driver's primary car is beyond repair at the discretion of Eldora and UMP DIRTcar officials. Backup cars penalized to the tail of the next subsequent race that night but retain original qualified position for Saturday. All cars will be subject to Eldora/UMP DIRTcar control from the time they enter the pit area until they are officially released after the race.

3. Only tow vehicles will be allowed inside pit area. One work area vehicle (ATV/Prowler/Pit Cart or similar), per entry, may be presented for credentialing at Registration – NO RIDERS PERMITTED UNLESS SEAT EXISTS – work area vehicles must remain in pit area, may be used only at specified times and may not be used on unrestricted areas of property. Please cooperate with these rules so that we may continue to offer this courtesy.

4. **All drivers are required to participate in "Meet & Greet" autograph sessions. Failure to attend may result in forfeiture of qualified position.**

5. It is strongly encouraged that the driver's last name should be clearly displayed in **BOLD BLOCK LETTERS** on both doors and across front of roof.

6. **The Hoosier LM20, LM30, LM30-S & LM40 compounds are the only tires permitted for competition. Tire rule will be enforced according to UMP DIRTcar rulebook.**

7. A Racing Electronics Solo or RACEceiver one-way radio and an electronic scoring transponder is mandatory for ALL on-track activity. You may use your own Westhold scoring transponder or rentals will be available at track.

8. All races will restart double-file in their entirety. Restart area and procedures will be detailed at driver meeting.

9. **All prize money will be mailed from Eldora to designee.** Checks will not be issued without a verified IRS Form W-9 (or W-8BEN for Canadian entrants) on file. All entrants are participating on their own behalf and are completely independent of the event promoter. As an independent contractor, entrants are responsible for prize money received including all income and withholding taxes that apply to such winnings.

10. Eldora reserves the right to alter show format and revise race procedures in the event of, but not limited to, car count, inclement weather, challenging track conditions and/or other extenuating circumstances. UMP DIRTcar will enforce and govern all mechanical, technical and tire regulations and rules. Mechanical, technical and tire infractions may result in a complete loss of all prize money earned. Eldora reserves right to refuse and/or remove any person from Speedway property.

THURSDAY & FRIDAY:

MULTI-CAR TIME TRIALS – Each night, multi-car qualifying, determined by random draw at tech-inspection, will be used to determine TWO groups for line-up purposes: Odd qualifiers in one group; Even qualifiers in the other group. The driver's fastest time trial run from either Thursday or Friday will be used to line-up Saturday night's heat races. There are two time trial-based positions in the Dirt Late Model Dream (see provisionals).

HEAT RACES – Each group (Odd/Even), each night, will be staggered into up to six heat races of 8 laps in distance. The inversion of the heat races will be determined by a random spin of the wheel by the night's fastest overall timer. Cars finishing 1st, 2nd and 3rd advance to that night's A-Feature, the balance of the finishers will advance into one of up to three B-Features. A group's first and second Heats will determine their group's B-Feature 1, third and fourth Heats will determine their group's B-Feature 2, and fifth and six Heats will determine their group's B-Feature 3.

B-FEATURES (\$6,150 posted Thursday and Friday) – Each group (Even/Odd), each night, will run up to three B-Features of 10 laps in distance. Cars finishing 1st and 2nd will advance to their respective group's A-Feature. All others receive \$75.

TWIN 25 LAP A-FEATURES (\$32,800 posted Thursday/\$46,650 posted Friday) – Each group (Even/Odd) will run one A-Feature of 25 laps; starting 24 cars. Positions 1 through 18 will be lined up by heat race finish. Positions 19 through 24 will be lined up by B-Feature finish.

SATURDAY:

HEAT RACES (\$6,750 posted) – There will be six Heat races of 15 laps in distance. The fastest 120 cars from the Thursday and Friday time trial sessions will lineup in staggered order of their fastest lap (ties broken by best average finish from Thursday and Friday races). The inversion, up to six cars, will be determined by a random spin of the wheel. Cars finishing 1st, 2nd and 3rd in the Heat races advance to the Dirt Late Model Dream. Cars finishing 4th-11th advance to a B-Feature, in order of finishing position. Heats 1-2-3 will determine B-Feature 1 and Heats 4-5-6 will determine B-Feature 2. Prize money for the Heat Races will be distributed as follows: non-advancing cars will receive \$125.

B-FEATURES & SCRAMBLES (\$11,600 posted) – There will be two B-Features of 20 laps in distance. Cars finishing 1st through 3rd will advance to the Dirt Late Model Dream. The remaining cars will restart in their current running order for a B-Scramble of 5 laps in distance. Prize money for the B-Scramble will be distributed as follows: 1)\$1,000; 2)\$500; 3)\$400; 4)\$375; 5)\$350; 6)\$325; 7)\$300; 8)\$275; 9-13)\$250; 14)\$225; 15-18)\$200.

PROVISIONALS – The two fastest qualifiers not advancing through the heat races will start 19th and 20th in the Dirt Late Model Dream (if they finished in a B-Feature qualifying position, they will be removed and the finish of that Heat race adjusted accordingly). After the B-Features, the drivers with the two best average finishes from Thursday and Friday's events that have not yet advanced will start 27th and 28th in the Dirt Late Model Dream. Ties in average finish will be decided by qualifying time.

DIRT LATE MODEL DREAM (\$196,525 posted) – The A-Feature will be 100 laps in distance, starting 28 cars. General Instructions

Section references are to the Internal Revenue Code unless otherwise noted.

Purpose of Form

A person who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) to report, for example, income paid to you, real estate transactions, mortgage interest you paid, acquisition or abandonment of secured property, cancellation of debt, or contributions you made to an IRA.

Use Form W-9 only if you are a U.S. person (including a resident alien), to provide your correct TIN to the person requesting it (the requester) and, when applicable, to:

1. Certify that the TIN you are giving is correct (or you are waiting for a number to be issued),
2. Certify that you are not subject to backup withholding, or
3. Claim exemption from backup withholding if you are a U.S. exempt payee. If applicable, you are also certifying that as a U.S. person, your allocable share of any partnership income from a U.S. trade or business is not subject to the withholding tax on foreign partners' share of effectively connected income.

Note. If a requester gives you a form other than Form W-9 to request your TIN, you must use the requester's form if it is substantially similar to this Form W-9.

Definition of a U.S. person. For federal tax purposes, you are considered a U.S. person if you are:

- An individual who is a U.S. citizen or U.S. resident alien,
- A partnership, corporation, company, or association created or organized in the United States or under the laws of the United States,
- An estate (other than a foreign estate), or
- A domestic trust (as defined in Regulations section 301.7701-7).

Special rules for partnerships. Partnerships that conduct a trade or business in the United States are generally required to pay a withholding tax on any foreign partners' share of income from such business. Further, in certain cases where a Form W-9 has not been received, a partnership is required to presume that a partner is a foreign person, and pay the withholding tax. Therefore, if you are a U.S. person that is a partner in a partnership conducting a trade or business in the United States, provide Form W-9 to the partnership to establish your U.S. status and avoid withholding on your share of partnership income.
