News and Notes: Bubba Race Parkway & Volusia Speedway Park (February 2015)

- All events will be officially sanctioned, but will not count towards the 2015 National Points Fund
- All events will follow the 2014 All Star Circuit of Champions rule book with the following amendment & recommendation:
 - Hoosier H-R15 RR tire has been approved for use
 - Tethers and torsion stops are strongly recommended
 - o Refer to the WoO bulletin for 2015 rule changes specific to the WoO if staying for those events
- All 2014 Members in good standing will receive 2 free pit passes per event
- Tow Money will be distributed as follows*:
 - \$300 for positions 1-5 (based on 2014 Final National Points Fund Standings)
 - \$200 for positions 6-8 (based on 2014 Final National Points Fund Standings)
 - \$150 for positions 9-10 (based on 2014 Final National Points Fund Standings)
 - 2014 National Champion receives extra \$200 tow \$ for tow paying races
 - One tow \$ / past champion's payment for multiple shows at same venue; must attend all shows to be eligible to receive tow \$
 - o Tow \$ will be paid at track following the final event at each venue
 - Top 10 positions will re-set on a weekly basis during the 2015 season (more information to be provided on this after the Florida events)
